### Treasurer's Message



Are you wondering how ASGA Chicago operates financially? Well, here is a brief overview.

A budget is set up at the beginning of the year for anticipated expenses (e.g. postage, coordinator boxes, website fee, annual report fee, advertising). Costs for social events are also figured in, as with the opening event this year at Broken Arrow. ASGA will be covering the food costs for our gracious hosts, **Keith and JoAnn Reifel**. \$10 of your annual membership fee paid to National is reimbursed back to our chapter to help with the expenses, so we also estimate the amount of dues to be received to offset expenses.

The golf outing costs are set by what the course charges and ASGA adds a fee for contest holes so we break even. We usually have a small deficit per outing because of the coordinator's coupon that was started a couple years ago. This is included in the annual budget as an expense.

And We're Off!!

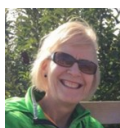

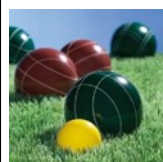
